These items consist of undecorated soda lime glass. Libbey has several manufacturing facilities, and Libbey's glass compositions vary slightly among facilities due to the availability of raw materials. However, the glass composition for all of our soda lime glass contains some or all of the following materials:

SiO₂ (silica dioxide)
Al₂O₃ (alumina, aluminum oxide)
Fe₂O₃ (iron oxide)
CaO (lime, calcium oxide)
MgO (magnesium oxide)
Na₂O (sodium monoxide)
K₂O (potassium oxide)
SO₃ (sulfur trioxide)
TiO₂ (titanium dioxide)
SrO (strontium oxide)
ZrO₂ (zirconium dioxide)

In addition to the materials listed above, soda lime glass manufactured by Libbey's facilities in Mexico may contain As₂O₃ (Arsenic trioxide). Libbey does not intentionally add lead or cadmium to the raw materials used in manufacturing its soda lime glassware. Accordingly, our soda lime glass material is considered leadless, non-toxic and non-radioactive.

Libbey is pleased to confirm that, to the best of our knowledge, as of the time and date of shipping from Libbey's manufacturing facility or distribution center, these Items meet all current applicable Federal and State standards for undecorated glass tableware, including but not necessarily limited to all applicable FDA Lead and Cadmium guidelines and Libbey's obligations under its consent judgment relating to California Proposition 65.
