Dear Valued Customer.

In order to meet the many requests for information concerning our Marabu ink line, this letter will act as a standard Marabu reply. All of our Marabu inks are manufactured in Germany. Marabu, as the ink manufacturer, is fully conversant and complies with all EU legislation.

We are pleased to certify the following specifications on our Marabu ink line:

- All Marabu inks are <u>heavy metal free</u> and comply with heavy metal limits according to ASTMF 963 Safety of Toys.
- Marabu inks are EN71 Part 3 Safety for Toys Migration of Specific Elements Compliant.
- Marabu confirms that in the manufacturing of their inks, phthalates or raw materials containing phthalates are not used.
- Alkylphenal ethoxylates (APEO) and PVC (Case–No. 9002-86-2) are not used as added ingredients by Marabu in the manufacturing of their screen and pad printing products.
- Marabu inks and auxiliaries meet and exceed CPSI Act of 2008. (2-10-09, 8-14-09, and 8-14-11)
- Marabu is ISO Certified:

DIN EN ISO 14001:2004

- Marabu confirms that they do not use any substances listed in the "Chemical Review List Report generated on July 15, 2011" or raw materials containing these substances.
- The use of perfluoroctanoic acid, perflouoroctane sulfonate or perlfuoroctane sulfonic acid or raw materials containing the above are not used by Marabu.
- ROHS Compliant (EU directive 2002/95EC of January 2003 ROHS)
- Marabu confirms the none-use of SVHC substances in the manufacturing of their products. (See attachment dated 6-25-10)
- All printing products supplied by Marabu are "Reach Compliant"!
- Marabu uses only chemicals that are registered under TOSCA.
- Marabu is well versed with California Proposition 65 and how it relates to our inks and has an ongoing program to monitor California regulations as it relates to keeping our Marabu inks compliant to the California Proposition 65.
- Third Party independent ink test reports may be requested by contacting our Customer Service Department. Our tests were completed April 2012.
- IMDS: (Automotive Industry) Excluded. All Marabu inks comply with requirements of exclusion list GADSL for screen printing/pad printing inks cured. Amount of ink residue in a car is miniscule.
   Refer to ROHS and MSDS information.
- Three of Marabu inks meet the requirements of USP24, NF19, 2000 for Biological Test for Plastic,
   Class VI 70°C. The three inks are TPR, TPU, and PP. (Medical grade Able to be used in human body).
- Marabu confirms that they don't use any latex, animal derived materials or DEHP, DBP or BBP and no raw
  materials containing these substances, according to their chemical constitution in the manufacturing of their
  screen printing inks, pad printing inks and auxiliaries.

- Marabu confirms that in the manufacturing of inks, solvents and hardeners, no raw material of BPA is used according to their chemical constitution.
- Marabu confirms the nonuse of any Fluoro Octanoic Acid.
- Marabu confirms the non use of Hexavalent Chromium in their inks.
- DIN 53160 Resistant to sweat / saliva
- Marabu doesn't use or buy Conflict Minerals from Kongo!
- Marabu's TPU ink series is Okeo-Tex Standard 100 Compliant. Confidence in Textiles!
- Marabu as a company and their inks are a Sony Green Partner Company.
- Marabu has been awarded the SGIA's Sustainability Recognition Award 2011. This is the second year in which Marabu has been presented this award.
