Between Numo and our parent, Kolder, we have been responsible for the development of many, if not most, of the innovative beverage insulators on the market today.

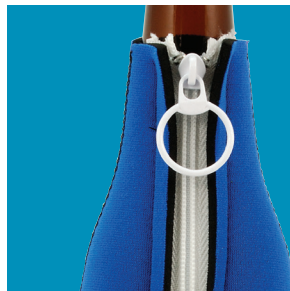
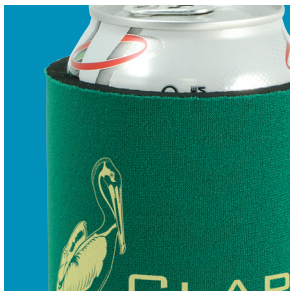
**Two tone insulators** – the first insulators to use different fabrics to achieve multi-color looks without multi-color imprints.

They were not always a cheaper mousetrap, but they were always a better one due to their inherent improved functionality.

Last year, we were very excited about our then-new BudBear™ and Flying-V tablet stands, both of which have new anodized colors this year.

Newly-developed items for 2013 include our Maglione™ and Rappotto™ tablet & laptop computer sleeves, the new Snak-a-lope™ reusable sandwich bag, and the Kase™ smartphone holder.

Of course, we already have plenty more items in various stages of development. Look for them to be introduced in 2013!

Quick prototypes + quick order turnarounds + our US-based product development group equate to a streamlined process. # RESPONSIBILITY

At Numo, we hope to *tread lightly* in all that we do.

We recognize that manufacturing consumes resources that are finite. Whenever possible, we choose alternatives that diminish our resource consumption. We're not perfect, but we work so that the sum of our choices this year amounts to a more responsible company than we were last year, and we hope that next year's Numo will be even better.

Some of the items of which we are most proud:

- » All of our cut neoprene and scuba scrap is re-used. Our waste does not end up in landfills.
- » All of our facilities have undergone lighting retrofits that have dramatically reduced electricity usage.
- » We have moved a large dividing wall in one of our facilities to reduce our air conditioning needs.
- » We just completed a roofing upgrade that will also impact electricity usage for our largest facility.
- » We have a testing program and protocol in place to ensure the products we ship to our customers are safe.
- » All of our facilities take part in a recycling program for all paper products.

We are proud to offer items that allow our customers to tread lightly also. Those include:

- » Any product using our EcoCoolie foam. (Contains >80% post-consumer recycled material.)
- » Klutch lunch totes represent an alternative to single-use paper and plastic bags.
- » Our new Snack-a-lope is made from an EcoTwill (a blend of RPET and organic cotton) and also offers an economical alternative to disposable plastic lunch bags.
- » We make a point to offer reusable coffee mugs and water bottles as alternatives to the single-use disposable kinds.

Most full-color magazines, catalogs, brochures, and retail packaging use some form of four-color process (a.k.a. "4CP" or "CMYK") to be able to render photos, illustrations, and graphics that use shading or gradients. Any of this kind of imagery can be applied to certain Numo items for a surprisingly reasonable cost.

### THE PROCESS

Four-Color Process gets its name from the fact that *four colors* are used to create a very large gamut of color. The four colors are **Cyan** (a bright aqua blue), **Magenta**, **Yellow**, and **Black**, hence the "CMYK" you see used as another term for Four-Color Process. (The "K" stands for Black because Blue had already staked its claim on the letter "B".)

By printing various amounts of each of these inks on top of one another, other colors can be shown. For instance, printing some Yellow and Cyan in the same spot will render a green color. Add some Black to it and the green gets darker.

The printing process determines how much of each of these colors to be applied to the paper (or whatever material you're printing on).

### SUBLIMATION

For most of our 4CP printing, Numo uses sublimation. Without getting into too much science, what happens is a mirror image of your imprint gets printed onto paper, then the paper is placed tightly against the product receiving the imprint. Adding some heat allows the printed image to transfer from the paper to the item.

The paper with the mirror image is called a transfer, and it can be printed on specially modified inkjet printers or on commercial printing presses.

One thing to note is that sublimation ink is transparent (It's technically a dye, rather than ink.), so it needs to have a white surface in order to show up properly. If you want a purple background behind your logo, that purple gets printed along with the imprint itself rather than depending on the material color behind it.

# FOUR-COLOR



## WHAT 4CP IS GOOD FOR

4CP really shines when you're using photographs or more complicated art:

**Photos.** The most obvious use would be a photo of a product, but also consider photos of facilities (past, present, or future) or of key players. (Real estate agents or political candidates are a natural fit here.)

**Art.** A painting or illustration, or a nice background texture can enhance many brands.

**Complicated brand images.** Many modern brands have logos that depend on things like 3-D shading or shadows and highlights. Much of this would be tough to reproduce in traditional screen printing, but it works beautifully in 4CP.

## THINGS TO AVOID WHEN USING 4CP

Of course, there are some trade-offs when dealing with 4CP sublimation.

Large areas of flat color (like in the background) can look uneven in some cases. Adding some texture pattern to these areas will hide the subtle irregularities. Grays and earth tones can be particularly hard to keep consistent in large areas.

White backgrounds on some fabrics can look a bit dingy in some cases. On can or bottle insulators, we recommend using white as only an accent color in the design.

Some colors cannot be reproduced by 4CP. Of particular note are some bright oranges that don't come out quite as intense, and royal or navy blues can tend to shift a little towards purple.

## 4CP ARTWORK SETUP

4CP sublimation doesn't require vector art quite like some screen printing does, but it's still very helpful. It is necessary, however, to have high-resolution art. This means at least 300dpi at the final printed size. High-res photos or illustrations can make for relatively large file sizes, so please make sure you consider that before emailing. Files up to about 50MB can be uploaded via the Numo website. (Look for the "Upload Artwork" link on nearly every item page on our site.) For files larger than 50MB, we recommend using one of the free file sending service websites available.

Your art can be set up in RGB or CMYK color mode. If there are any PMS colors you wish us to try to match, please check with us before placing your order. Be aware that many PMS colors cannot be matched with perfect accuracy using 4CP printing.

We strongly recommend sending your art as a layered PSD (Photoshop-native) file.

# Scuba vs. Neoprene

## SO, WHAT'S THE DIFFERENCE?

Kolder, Inc. (NUMO's parent company) began making beverage insulators out of **neoprene** in 1982. Back then, the primary beverage insulator was the old, fat, extruded insulator. Neoprene offered great insulation properties in addition to being compact and offering multi-color imprints. Neoprene was the Cadillac of beverage insulators, but discerning consumers were willing to pay the price for a superior product.

**Scuba** arrived on the scene in the late 1990's. It was developed as a cheaper alternative to neoprene for beverage insulators. The material itself is constructed of an "open cell" polyurethane foam with a polyester fabric on one side and a tricot on the other. Conversely, neoprene is a "closed cell" rubber-based product with a polyester or nylon fabric on both sides. Scuba's tricot doesn't stretch nearly as well as nylon and poly, but guess what, it's cheaper!

(The irony is that the actual suits worn by scuba divers are really neoprene.)

You might be asking yourself, what we mean by "open cell" and "closed cell"? Well, take a look at this picture. You can see air "bubbles" in the foam of the scuba (on the left), whereas you can't see the bubbles in the neoprene (on the right). When we say "open cell", we actually mean that we can see the bubbles in the foam, while neoprene is "closed cell" because we can't. The bubbles in neoprene are still there, but they're just not visible ("closed-cell" is a bit of a misnomer).

Now for the science bit... heat is transferred in three ways: conduction (transfer through physical contact), convection (transfer through the movement of air), and radiation (complicated). The rate at which heat is transferred into your beverage is a function of all three, and when you put an insulator on it, you're slowing that transfer in all three ways. Any insulator inhibits air flow around the can or bottle, and therefore impedes convection. When you have a neoprene insulator on a can or bottle, heat has to be transferred through a much denser, less conductive, material than scuba. What happens on a small scale is that in scuba foam, the heat is able to transfer through a little bit of polyurethane, and a lot of air (bubbles). So neoprene, which is mostly rubber, is a better insulator than scuba.

You might have heard about the "R-value" of insulation. That is a measure of the rate at which heat is transferred through something. The higher the R-value, the better your insulation in your attic and walls, right? Well, neoprene has a higher R-value than scuba.

# Printing on Drinkware

## UV INKS

UV-cured inks are a relatively new technology that allows us to print directly onto ceramics and glass. It has become the default for most single-color printing on many of our drinkware items.

Using UV Inks has several advantages over traditional ceramic inks:

- They offer some colors that would be impossible or cost-prohibitive with ceramic inks. Bright pinks and purples are no problem for UV inks.
- They are more opaque, reducing the need for double-printing or printing down white to add a color on top of it in many cases.
- The cure time is a fraction of what traditional ceramic inks require. (30 seconds compared to about 2.5 hours!)
- There is less danger of burns, fire, etc., so our staff and equipment are safer.
- Their formulations are free from lead, cadmium, and other heavy metals, complying with CPSIA standards, and no labeling needed for California Prop 65!

UV inks do have a few drawbacks, though. There is some loss of durability compared to traditional inks, and they are slightly more prone to scratching. In perspective, though, our testing shows that UV inks will hold up to over 500 washes in standard domestic dishwashers, which should be plenty long for most promotional uses.

## CERAMIC INKS:

Ceramic fired inks are the tradition when printing onto glass or ceramics. They are extremely durable, and all the inks we use at Numo today are free of lead. However, after application to the item, they need to be fired in a lehr for over 2 hours at just over 1100°F. If, after firing, any printing problems are found, it's a time-consuming process to test another run to verify the issues have been resolved.

Also, to clarify, the name "ceramic" refers to the ink's formulation, not the surface onto which it's applied. Ceramic inks are also used on glass items.

## DECAL:

For very tight registration or items that have a concave sidewall, we use ceramic inks on a decal. These decals are screen-printed onto paper, with a layer of transparent ink covering the design. Once dry, the printed paper decals are soaked with water, releasing the imprint from the paper. The transparent layer, called a "cover coat" keeps the artwork together after it's released from the paper. The imprint can then be slid off the paper and onto the item, the water squeegee'd out (just like the decals on a model airplane), and then fired in the lehr just like the ceramic inks mentioned above.

## FX INKS:

Magic ink is thermochromatic, meaning it becomes transparent, or "disappears", when the temperature is raised to a certain point. Numo has magic ink available in black, and it can be printed over your imprint so that your message is revealed when the ink is heated by the beverage in the cup. Magic ink is printed as an additional color on top of one or more ceramic inks. The creative possibilities of using an imprint that changes are almost limitless!

## PRECIOUS METALS:

Numo offers decoration using precious metals (gold or silver) for an upscale look to your message. These can be used within the main imprint area, or as a halo band around the lip of the item. Contact Numo for details on pricing and availability.

## SUBLIMATION:

Sublimation, often used interchangeably with "Four-Color Process" allows us to put photographic-quality images onto some of our ceramics items for a reasonable cost and very low minimum quantity. In sublimation, the image gets printed onto paper first, then transferred to the item. Unlike decal, though, sublimation simply uses about 30 seconds of heat and high pressure to make the transfer happen. It does not need the long curing time like ceramic inks.

The main negatives with sublimation is the limited number of items it can be used on, and some PMS colors are not able to be matched. (See the article on Four-Color Process on pages 6-7 for more information.) Sublimation inks are also transparent, so they need an opaque white surface in order for them to show up.

However, our sublimation process is compliant with CPSIA and Prop 65 standards.

**Magic Ink becomes transparent**, or “disappears” when it gets hot. The heat from hot coffee or tea warms up the ceramic mug, and causes the Magic Ink to change from an opaque black to clear, revealing anything printed behind it. When the mug cools back to room temperature, the ink becomes opaque once again.

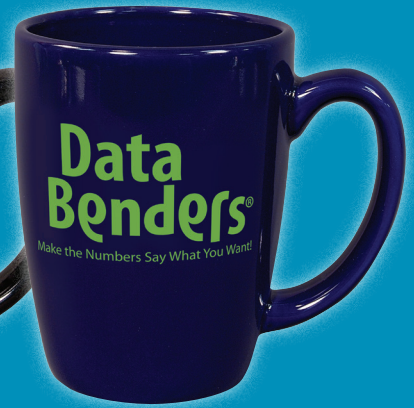
To make a great Magic Mug promo, think of ways you can use Magic Ink to hide a portion of your message, then reveal it later. Things like a curtain that disappears to reveal what's behind. Or perhaps an image of a computer screen or TV that turns on to reveal your message on-screen. Showing a question, then revealing an answer is a popular idea. A night sky can turn to daytime.

The main thing to watch out for is that the ink can't change into something else. One possibly helpful way to think about it: Print out your base art onto a sheet of paper. For the Magic part, print or draw it on a piece of clear film. Lay the film over the art. This would be the “cold” iteration of your concept. Lifting the film back off the art will show the “hot” iteration. If your concept works in this manner, it will probably work with our Magic Mugs.

Numo will route shipments the best way unless otherwise specified. Fully insured shipments must be clearly stated on order. Glassware and ceramics will incur a charge of \$5.00 (g) per carton for protective cartons when shipping via small package carriers (i.e. UPS, FedEx) to insure safe delivery. This charge will be incorporated in the final freight charges.

**Freight Claims:** Title of goods passes to the buyer once goods leave Numo. All goods should be inspected for shortage and/or damage and duly noted by the consignee on the delivery receipt if evident at time of delivery. All claims must be filed with the carrier within 15 days of receipt of shipment. Numo will assist as much as possible in filing claims but will not be responsible for the payment of such claims.

## OTHER ORDER INFORMATION

**Acknowledgements:** Order acknowledgements are typically emailed after order clarification to avoid misunderstandings and should be carefully examined with regard to all aspects of the order. All orders will be produced as acknowledged and no allowances will be made for failure to correct any discrepancies before production.

**Cancellations:** In the event an order is cancelled, a cancellation fee of \$37.50 (g) in addition to all charges associated with work already completed will be invoiced.

**Returns or Adjustments:** All claims must be made within 30 days of shipment. Return orders will not be accepted without factory approval and a return authorization (RA) number. No allowance will be made for outdated catalogs or incorrect pricing. Numo reserves the right to change prices without notice.

**Terms:** Prepayment or net 30 days with approved credit. Accounts unpaid after 30 days will incur a late charge of 1% per month on the unpaid balance. Numo accepts Mastercard, Visa, Discover, and American Express for your convenience. Returned checks: \$31.25 (g) per check per return (in addition to any charges from financial institutions).

## CALIFORNIA PROPOSITION 65

Numo decorates glass and ceramic products using printing material that will comply with current U.S. Food & Drug Administration (FDA) Guidelines for heavy metal release standards, however California does not recognize the Federal standards and chooses to enforce its own standards.

The Safe Drinking Water and Toxic Enforcement Act of 1986, referred to as Proposition 65, requires that consumers be warned about products that may contain one of over 800 listed substances. Among these substances are lead and cadmium. Proposition 65 does not ban any product from being sold, it just requires a warning to the consumer.

A warning label is all that is required to comply and exact warning language must be used.

Numo offers decorating enamels that comply with Proposition 65 that do not require warning labels:

We offer ceramic enamels that can be used for glass and ceramics with either direct screen printing or decal application. Some colors are not available, please contact factory.

We offer organic based colors for one color imprints

We offer four color process sublimation on ceramic mugs

Numo continues to offer low lead, and no lead high gloss enamels for those customers who require them. We will apply warning labels for all glass or ceramic products destined for California that require these traditional enamels at no additional cost.

## CPSIA
